Hawthorne, her brother Nathaniel Hawthorne, and her sister-in-law Sophia Peabody Hawthorne. There are letters to Maria Louisa Hawthorne from her nephew Julian and her sister-in-law Sophia Peabody Hawthorne, dating from 1843 to 1852.
