**Abstract:** The Bruce Jay Friedman papers, 1953-2012 (bulk 1998-2012), document the life and work of journalist, novelist, playwright and screen-writer whose work emerged on the New York City scene in the 1960s. Friedman mastered the dynamics between fiction and non-fiction, the narrative, and writing for the stage. The collection consists of extensive writings, correspondence, photographs, interviews, teaching material, printed material, and personal records.

### **Creator History**

Bruce Jay Friedman, a novelist, playwright, short-story writer and Oscar-nominated screenwriter was born in New York City on April 26, 1930. Friedman attended the University of Missouri and earned a B.A. in Journalism in 1951. He spent two years as an Air Force officer during the Korean War and after his service established himself as a writer for men's magazines. Friedman became the executive editor of three major men's magazines *Men, Male,* and *Man's World,* before publishing his first novel *Stern* in 1962. Friedman has been well known for his off-Broadway hit *Steambath,* and he has since published another seven novels, several short stories, plays and numerous screenplays including *Splash* in 1984.

## **Scope and Content Note**

The collection heading provides a starting date of 1953, which represents the earliest document located in the archive. The collection documents Friedman's later plays, novels, short stories and is particularly strong in his later works of non-fiction, including many

articles and essays. The varied genres of Friedman's writing are represented in the archive as well as incoming and outgoing correspondence, interviews, teaching materials, contracts, permissions, royalty statements, photographs, printed material and some multimedia.
