Pforzheimer Collection and Shelley and his Circle

The Carl H. Pforzheimer Collection of Shelley and His Circle is one of the world's leading repositories for the study of British Romanticism. Comprising over 20,000 items, the collection is conceptually centered on the life and works of the poet Percy Bysshe Shelley and his friends, relatives, and contemporaries. Formerly a part of the much larger and now dispersed Pforzheimer Library, the Pforzheimer Collection came to The New York Public Library in 1986.

Related materials

In addition to manuscripts by Walter Edwin Peck, the Pforzheimer Collection also holds four copies of his *Shelley: His Life and Works*, each bearing his autograph, and some of his published critical works. Also held is a small collection of newspaper clippings on Peck, relating to his final years and death.

Arrangement

This guide considers the Walter Edwin Peck manuscript materials in four series: Series I, Writings; Series II, Correspondence; and Series III, Related documents and miscellanea.

Scope and content

The Walter Edwin Peck manuscript material in the Pforzheimer Collection consists of writings and correspondence. The writings include: a typescript introduction to a proposed printing of Shelley's will, and a holograph essay, "Shelley and 'Constantia' (Claire Clairmont)." The bulk of the correspondence is addressed to Carl H. Pforzheimer and dated between 1922 and 1931. Accompanying material includes: a number of typescript letter copies from Pforzheimer to Peck, and Houghton Mifflin Company documents relating to sales of Peck's Shelley biography.
