Hutchinson to Thomas Farrer : 1 autograph letter signed : 12 Apr 1832 : (BLES2.157b) : from Palmerston House : begins, "On the part of Lady Harriet Dorsay I am requested to ask your opinion on the following points. Count Dorsay has suggested that an application should be made to the Irish chancellor, in his name and that of his wife, for an allowance ...".

· From Thomas Farrer to J. H. Hutchinson : 1 autograph letter signed : 18 Apr 1832 : (BLES 2.159) : from Hambleden, Henley on Thames : begins, "Your letter of the 12th reached me only yesterday. I very

much regret that the state of my health has prevented me from giving that speedy attention to Lady Harriet D'Orsay's arrangements ...".

· From Thomas Farrer to Luke Norman : 1 letter (scribal copy) : 9 May 1832 : (BLES 2.158) : from No. 1 Brunswick Square, Brighton : begins, "I am much obliged by your letters of the 1st and 2nd instant, which should have been sooner answered, but that I am obliged by the state of my health to reside at present at Brighton ...".

· From Thomas Farrer to Luke Norman : 1 autograph letter signed : 21 May 1832 : (BLES 2.160) : from No. 1 Brunswick Square, Brighton : begins, "I am much obliged by your letter of the 14th instant. I should not have hesitated, had the draft answer been ready, at sending it to you open, and should have indeed requested your perusal of it ...".
