- 1853, Jun 2. A.D., 2 p. (1 leaf). Plea and notice in case of Robert B. Courtney and others against Nelson Maddox, administrator of the estate of William T. Courtney.

- 1861, Mar 16. Printed letter signed, 1 p. To the Governor of the State of Mississippi. Countersigned by William H. Seward, Secretary of State.
- 1861, Apr 7. Postmark on envelope addressed to Parke Godwin, Esq. franked by President Lincoln.
- 1861, May 24. A.L.S., 1 p. To Lieutenant General Scott. [In separate slipcase].
- 1861, Jul 2. D.S., 1 p. Original order suspending the writ of *habeas corpus* between New York and Washington. Countersigned by William Henry Seward
- 1861, Aug 7. A.L.S., 1 p. To the Honorable Secretary of War, requesting appointment of four officers to Kansas Volunteers.
- 1861, Aug 16. A.D.S., 1 p. Endorsed reply by Lincoln on A.L.S., Aug 16, 1861, from Major General George B. McClellan.
- 1861, Aug 22. A.L.S., 1 p. To Captain Thomas G. Pitcher, accompanied by blank envelope endorsed (on verso) by [Capt. Pitcher]
- 1862, Jan. Letter, 1 p. with envelope. To George Dad[...?] Written by John Hay under President Lincoln's direction
- 1862, Jul 1. A.L.S., 1 p. To Major General McClellan.
