**Abstract:** The collection consists of correspondence and other papers of prominent members of the interrelated McKim and Garrison families collected by Margaret McKim Maloney and others. Included are papers of architect Charles Follen McKim, abolitionists James Miller McKim, William Lloyd Garrison, James H. Garrison, and their descendants. Papers of James Miller McKim, 1828-1882, contain correspondence, accounts, family and personal miscellany, and clippings. Papers of his son Charles Follen McKim, 1857-1908, include correspondence, his diary of a walking tour in 1863, speeches, personal miscellany, and a sketch by Charles Dana Gibson, and printed matter. Also included is correspondence of Margaret McKim Maloney, Wendell Phillips Garrison, William Lloyd Garrison, Jr., Frank J. Garrison, Moncure Conway, Wendell Phillips, and Edward and Mathilda Kyllman.

## Creator History

James Miller McKim (1842-1877) was a Presbyterian minister who became an abolitionist and organizer of freedmen's aid societies. McKim first worked as an agent for the Pennsylvania Anti-Slavery Society, editing the Society's newspaper, the *Pennsylvania Freeman*, before organizing the American Freedman's Union Commission that sought to aid and promote the newly freed black population of South Carolina's Sea Islands. After journeying to these islands, he published a report, *The Freedmen of South Carolina* (1862). He was one of the founders of the *Nation*, a weekly magazine where his son-in-law Wendell Phillips Garrison would later be a literary editor. McKim married Sarah Allibone Speakman (1813-1891) in 1840 and had two children Charles Follen (1847-1909) and Lucy (1842-1877).

Charles Follen McKim was a prominent architect and senior partner of McKim, Mead & White, one of the leading architecture firms in the late 19th and early 20th Centuries. McKim, one of the first Americans to be trained at the *cole des Beaux-Arts* in Paris, was known for pioneering the Colonial Revival, establishing a national style of classicism and for the collaboration between architecture and the fine arts. Among the buildings designed by McKim were the Trinity Church in Boston, the former Pennsylvania Railroad Station, the J.P. Morgan Library and the Boston Public Library. McKim was also founder of the American School of Architecture, which later became the American Academy of Rome. McKim was married twice, to Annie Bigelow in 1874 and to Julia Amory Appleton in 1885. He had one daughter with Annie Bigelow, Margaret S. McKim, who married William Maloney. Lucy McKim was a pianist and violinist who collected slave songs. Jointly with her husband, Wendell Phillips Garrison, she compiled and published a collection entitled *Slave Songs of the United States*.

William Lloyd Garrison (1805-1879) was an abolitionist, editor and religious reformer. He spent most of his professional career working for abolitionist periodicals, first co-editing the *Quaker Genius* of Universal Emancipation with Benjamin Lundy before founding the weekly paper *The Liberator* that he published from 1831 until 1866. Garrison was also one of the founders of the American Anti-Slavery Society, authored the society's Declaration of Sentiments, as well as the *Friends of Universal Reform*. In addition to his abolitionist activities, Garrison was a strong proponent of temperance, women's rights, anticlericalism and a rejection of the Constitution, beliefs that made many view him as a radical and controversial person. He married Helen Eliza Benson (1811-1876) in 1834 and the couple had four children who survived past infancy, William L. Garrison, Wendell Phillips Garrison, Helen Frances Garrison and George Thompson Garrison. His brother, James Holley Garrison (1801-1841) served in the United States Navy.

## Scope and Content Note

The collection is composed of materials collected by William and Margaret Maloney with additional materials purchased by The New York Public Library with funds from the Maloney family. The collection consists of personal papers of Charles Follen McKim, James Miller McKim, James Holley Garrison, William Lloyd Garrison, Moncure Conway and others. Papers of James Miller McKim, 1828-1882, contain correspondence, accounts, biographical material, address books, scrapbook, and clippings pertaining to his career as an editor and abolitionist. Noted correspondents include Samuel Joseph May, James and Lucretia Mott, Passmore Williamson, Henry B. Stanton and William Still. Papers of his son, Charles Follen McKim, 1857-1908, include correspondence, speeches, memorabilia, and printed matter. McKim's career as a prominent architect is documented with correspondence from such noted architects as Philip Brooks, Cass Gilbert, Sir Aston Webb, George Brown Post, Stanford White and William Mead, among others. Also included is a sketch of McKim by Charles Dana Gibson. Correspondence, 1903-1930, and other papers of McKim's daughter, Margaret McKim Maloney are also represented in the collection. Papers of William Lloyd Garrison, 1839-1879, include correspondence and writings from his career as an editor, an abolitionist and a religious reformer. Included are unpublished notes and published writings. Papers of his brother, James Holley Garrison,

ca. 1814-1840, include a diary of Garrison's battle with alcoholism and his time in the United States Navy, an account of an attempted suicide and biographical material. Letters to Moncure Conway, 1856-1885, are also represented in this collection as well as the correspondence of Wendell Phillips Garrison and Edward and Otto Kyllmann.

### I. James Miller McKim Papers 1836-1874

#### I.A. Correspondence

James Miller McKim's correspondence documents his early career as a minister, his work as an abolitionist and his role as a founder of The Nation. Letters from family are primarily from his brother John McKim and from his son, Charles Follen McKim, while he was a student at Lawrence Scientific School, Harvard University and cole des Beaux Arts in Paris. Letters from friends and associates detail McKim's administrative roles within the Pennsylvania Anti-Slavery Society and the American Freedman's Union Commission, including letters from abolitionists such as Samuel Joseph May, James and Lucretia Mott, Passmore Williamson, Henry B. Stanton and William Still. McKim toured extensively for his abolitionist work and correspondence reflects these travels. Included is correspondence with European abolitionists, such as Mary Estlin, George Thompson and James Haughton, from McKim's tour of Ireland, England and Scotland in 1853. Also included are letters McKim wrote to his wife while visiting the society of free blacks living in the Sea Islands of South Carolina in 1862 and a letter by order of Ulysses S. Grant, signed by Theodore S. Bowers, granting McKim permission to travel to the Southern states under military protection. There are copies of letters from Mary Brown to her husband, John Brown to the Governor Wise of Virginia, with replies from both men, shortly before John Brown's execution as well as a letter from Mary Brown to McKim thanking him for accompanying her in retrieving her husband's body from Harper's Ferry. Correspondence with E.L. Godkin, Henry Villard and various stockholders detail his involvement as a founder of The Nation.

II. Charles Follen McKim Papers 1854-1908

II.A. Correspondence

Charles Follen McKim's correspondence consists of letters from family and notable architects, artists and writers. Family letters are from McKim's father, James Follen McKim, his mother, Sarah Speakman McKim and sister Lucy McKim Garrison. Also included are ten letters from McKim to his childhood friend Frank Jackson Garrison. Letters regarding McKim's architecture career reflect his work, particularly his designing of the Boston Public Library, the formation of the American Institute of Architects in Rome, and his role at the 1893 Chicago World's Fair. There are letters from such noted architects as Philip Brooks, Cass Gilbert, Sir Aston Webb, George Brown Post and McKim's partners, Stanford White and William Mead. In addition, there are letters from artists commissioned by McKim including Daniel Chester French, Frank Millet and Edwin A. Abbey and one sketch by Abbey. There are letters congratulating McKim on both architectural and honorary achievements, such as completing the Boston Library and receiving the King's Medal. Also included also are letters of condolence written upon the occasion of Stanford White's murder. Other notable correspondents are Charles William Eliot, Frederick Law Olmsted, Henry Villard, Francis James Child and Edith Wharton, among others.

Letters sent by William Lloyd Garrison are comprised of both personal letters and those regarding his abolitionist activities. Garrison often wrote to fellow abolitionists, such as a letter to Nathaniel Rogers regarding the situation of a runaway slave whom both men had aided and one to Phebe Jackson on an upcoming meeting of the American Anti-Slavery Society. There are letters coordinating his lecturing engagements and his journalistic activities, such as a letter to the publishers of the *World* on his inability to lecture due to poor health and one to William Hayes Ward on corrections for an article he wrote for the *Independent*. Garrison also wrote letters as a way of forging connections for friends and associates, introducing Parker Pillsbury to Henry Wigham, Jr., A.M. Safferty to Loring Lothrop and Edward Kyllmann to Judge Hugh L. Bond and Gilbert Pillsbury. There are letters to friends, such as Theodore Parker on his attendance at the funeral an aunt and to George Stearns thanking him for a bushel of pears. There are many letters to Edward Kyllmann giving news of the Garrison family, such as the Eastern Railroad Revere train wreck in 1871 in which his son, William Lloyd Garrison Jr., was seriously injured, the aftermath of the Great Boston Fire of 1872 and a dispirited letter on the paralysis and expected death of his daughter-in-law, Lucy McKim Garrison. There is one letter to his son Francis (Frank) Garrison that Garrison wrote with his daughter Helen (Fanny) Garrison Villard. Also included is a typescript copy of a letter he wrote to James Kirke Paulding on securing the release of his brother, James Holley Garrison, from the Navy due to his poor health and a copy of Paulding's reply.

James Holley Garrison's leather bound diary contains accounts of Garrison's early years as an apprentice in various trades, his introduction to alcohol and consequent alcoholism, his years as a sailor in the United States Navy and a daily account from his later years as he was working on a relative's farm and suffering poor health. Pasted into the diary are newspapers clippings of homemade cures for ailments, cooking recipes and instructions for pickling and preserving fruit, vegetables and meat. The diary, edited by Walter McIntosh Merrill, was published as *Behold me once more; the confessions of James Holley Garrison, brother of William Lloyd Garrison*.

Wendell Phillips Garrison's correspondence consists of both family letters and letters regarding research on the life and career of his uncle James Holley Garrison. There are also two letters Garrison wrote introducing Edward Kyllmann as well as letters to Kyllmann himself on the publishing profession and to give him news of the death of his mother-in-law Sarah Speakman McKim. Letters from family members consist of a letter from William Lloyd Garrison on details on a visit and from his mother, Helen Garrison, on a visit from Sarah Grimke. There is material pertaining to Garrison's attempts to acquire a book, "The Evils and Abuses of in the Evils and Abuses in the Naval and Merchant Service, Exposed" by William McNally. There is a letter from the Navy Department on the Bureau of Navigation on the course of the U.S.S. North Carolina, a ship which James Holly Garrison sailed on, and a letter from W.E. Griffis containing additional information about the same ship.

Moncure Conway (1832-1907) was an American abolitionist, writer and minister. First of the Methodist faith, he then converted to Unitarianism before abandoning that to become minister of the South Place Ethical Society in London. Letters to Moncure Conway were purchased with funds from the Margaret Maloney fund. The bulk of the letters (15) are from Wendell Phillips. Phillips writes to introduce Richard Hinton, an abolitionist journalist who was coming to England to study labor issues, and Martin Milmore, an artist who was going to Rome to sculpt the Soldiers' and Sailors' Monument for the Boston Common. He also writes Conway to keep him abreast of changes, and divisions, in the American abolitionist community as well as to counsel Conway on his feelings of isolation and censure from it. There is one letter from Phillips to Conway's wife, Ellen. There are two letters from W.H. Furness, one discussing Unitarian minister Robert Collyer's move from his Chicago church to the Community Church in New York City and a second on the death of his wife, Annis. There is one letter from George Thompson welcoming Conway to England when he first arrived.

Edward Kyllmann was a cotton merchant of German descent who lived in Manchester, England. Both Kyllmann and his wife Mathilda were involved in abolition work and the women's suffrage movement. Mathilda sat as treasurer of the Manchester Society for Women's Suffrage. Letters to Kyllmann are from various members of the Garrison family and give news on family matters and political activities. The bulk of the letters, including three typescripts, are from William Lloyd Garrison, Jr. who wrote often and affectionately. His letters are primarily about family matters, but also discuss politics and the effects the Panic of 1893 on the American economy. Often mentioned are friends Joseph Simpson and the Steinthals, the family of Unitarian minister S. Alfred Steinthal. Also included is one letter to Helen Villard written by Edward and Mathilda Kyllmann. Their son, Otto Kyllmann, was the a senior partner of the publishing firm, Constable & Co. Letters to him are three in number, two from Frank Jackson Garrison and one from Oswald Garrison Villard concerning Villard's book *Inside Germany*, published by Constable & Co., and Villard's lunch with Franklin Delano Roosevelt.
