Abstract: The New York Library Club was founded at Columbia College in 1885 by Melvil Dewey for the purpose of promoting libraries and librarianship in New York City and its environs. The collection dates from 1885 to 2002 and contains administrative material, including meeting minutes, correspondence, financial records, and membership and programming materials.

Creator History

The New York Library Club was founded at Columbia College in 1885 by Melvil Dewey for the purpose of promoting libraries and librarianship in metropolitan New York City. The club's activities have included general meetings with guest speakers, panel discussions with librarian professionals, field trips, banquets and as scholarship sponsors. The club also publishes a newsletter called *Bulletin* and a yearly *Manual*. Membership is for all those interested in the profession. The club has no permanent headquarters.

Scope and Content Note

The collection consists of administrative records. These include meeting minutes, correspondence,

newsletters and manuals, programming material, and financial records.
