During the Civil War he was an inspector for the United States Sanitary Commission. He was appointed in 1884 librarian of the Enoch Pratt Free Library in Baltimore, a post he held until 1892. The bulk of the collection consists of letters addressed to Steiner chiefly in his capacity as inspector of the United States Sanitary Commission in Maryland. Most are from officials of the Sanitary Commission and concern inspection reports, medical and health conditions of troops, furnishing of hospital supplies, and related matters.
