Abstract

The Margaret Carson Papers document the work of one of New York City's leading classical music publicists of the 20th century. They consist of clippings, correspondence, promotional material, press kits, photographs, concert programs and itineraries.

Custodial History

Margaret Carson donated the Margaret Carson Papers to the Music Division in 1995. Additional files were received after her death in October 2007.

Processing Information

The collection was processed and cataloged in 2007-2008.

Biographical Note

Margaret Carson was born in Salt Lake City in 1911, and lived in Ohio from approximately 1920-1939. She majored in political science at the University of Toledo, and received a master's degree in social administration from Ohio State University. Carson's publicity work began in Ohio for the Toledo Community Chest during the years 1937-1938. She married Charles Carson, a reporter and editor in Cleveland, with whom she had a son, also named Charles. They divorced, and she found work in New York City with Constance Hope Associates, the leading public relations firm in the city. In the early 1940s she created the Margaret Carson Agency, where one of her clients was the opera star Gladys Swarthout. Carson was the press representative for the Metropolitan Opera from 1944-1954. After a year off, in 1956 she handled press for her friend Margaret Truman's wedding to Clifton Daniel.

Carson's major clients over the years included Leonard Bernstein, Barry Tuckwell, Michael Tilson Thomas and the New World Symphony, Benny Goodman, Neville Marriner, Mitch Miller, the Metropolitan Opera, the Cincinnati Symphony Orchestra, the Pacific Music Festival and the New England Conservatory of Music, among many others.

Her second husband, Carl Ruff, was a press agent and the father of her daughter, Carla. Ruff also adopted her son Charles, but the marriage ended in divorce. She married Robert Sherrod in 1961, editor for the Saturday Evening Post, but divorced him in 1972. Her son Charles, who died in 2000, led a successful career as a lawyer, including work with the Watergate trial and defending President Clinton during his impeachment hearing.

Scope and Content Note

The Margaret Carson Papers consist of files devoted to her publicity work with classical musicians such as Leonard Bernstein, Michael Tilson Thomas, and Barry Tuckwell; and organizations such as the Metropolitan Opera, the Cincinnati Symphony Orchestra, the New England Conservatory, and the New World Symphony. The majority of these materials date from the 1970s-1990s. Many of her early clients are not well documented. The Papers mainly consist of media clippings, correspondence, promotional material, press kits, photographs, concert programs and artist itineraries. Leonard Bernstein was one of Carson's most important clients; papers concerning him make up the largest portion of the collection devoted to a single artist. There are few personal materials in the collection.

Series Descriptions

Series I: General Office Files, 1938-2006, undated Arrangement: Alphabetical

7 boxes

This series consists of general files kept by the Carson Office, such as clippings and subject-specific folders used for research purposes. It documents Margaret Carson's career primarily through her correspondence and photographs.

Series II: Leonard Bernstein Files, 1944-2006, undated

39 boxes

This series documents Carson's publicity work for Leonard Bernstein during the last twenty years of his life and details much of the effort behind maintaining his legacy. There are six sub-series: Biographical Materials, Correspondence, Concerts, Productions, Speeches and Writings, and Clippings.

Sub-series 1 – Correspondence, 1972-1995 and undated Arrangement: Chronological and Alphabetical

7.5 boxes

This sub-series consists primarily of correspondence between the Carson Office and people or organizations that Amberson, Inc. worked with to promote Bernstein's concerts and productions. There are many letters or memos from Carson to the head of Amberson, Harry J. Kraut (often abbreviated as HJK), who delegated the majority of requests for Bernstein's time and energy. In addition, requests received by Carson were forwarded to Kraut or other appropriate personnel within Amberson. There are no letters from Bernstein to Carson. The correspondence is in two sets, in a chronological sequence of general office requests and in a set of alphabetical subject files Carson maintained for specific topics such as autograph and interview requests, and condolences on Bernstein's death.

Sub-series 2 – Biographical materials, 1945-2006 and undated Arrangement: Alphabetical

5 boxes

The materials in this sub-series focus on the facts of Bernstein's life onstage and off. Of note are files for the numerous awards given to Bernstein during the 1980s.

Sub-series 3 – Concerts, 1966-1995 and undated Arrangement: Alphabetical

11.5 boxes

The concert files that make up this sub-series are primarily those in which Bernstein directly participated, live and on stage. They document much of Bernstein's work as a conductor after he left the New York Philharmonic. Events documented include several milestone birthday celebration concerts for Bernstein and other important musicians; benefit and peace concerts; scholarship events; guest conducting stints with several major orchestras, including the Chicago Symphony and the Israel and Vienna Philharmonic;

New York Philharmonic events; and music festivals (particularly Tanglewood). Materials for recorded concerts can be found in sub-series 4.

Sub-series 4 – Productions, 1944-2004 and undated Arrangement: Alphabetical

10.5 boxes

This sub-series consists of files for Bernstein's compositions that were produced without his direct participation, and recordings, and television and video projects. It includes revue productions that took place before and after his death. Events documented include various productions 1600 Pennsylvania Avenue, Candide, On The Town and A Quiet Place; The Leonard Bernstein Jerusalem International Music Competitions; performances of Bernstein's Mass; memorial concerts for Bernstein; recording projects; and radio and television productions about Bernstein.

Sub-series 5 – Speeches and Writings, 1972-1992, undated Arrangement: Alphabetical

2 boxes

This sub-series documents Bernstein's non-concert stage and intellectual pursuits during the 1970s and 1980s. Of note are the materials for his Norton Lecture Series at Harvard University, titled *The Unanswered Question*.

Sub-series 6 – Clippings, 1957-2004 and undated Arrangement: Chronological

4 boxes

The clippings found in this sub-series offer a broad overview of Bernstein's life and career. Carson's organization of these files is maintained here by grouping them into feature articles, foreign press, obituaries and reviews.

Series III: Other Client Files, 1935-2007 and undated Arrangement: Alphabetical

59 boxes

A typical client file in this series consists of biographies, correspondence, press kits and releases, programs, promotional materials, schedules, photographs, and clippings. Much of the correspondence is between the Carson Office and people or organizations involved with the particular client, although some folders contain letters between Carson and her client. Some files are for artists who were only prospective clients, and never engaged Carson's services. Clients with substantial documentation include Antonio de Almeida, Alfred Brendel, the Cincinnati Symphony Orchestra, Benny Goodman, Neville Marriner, Mitch Miller, the Metropolitan Opera, the New World Symphony, the New England Conservatory, the Pacific Music Festival, Paul Sperry, Michael Tilson Thomas and Barry Tuckwell.
