Abstract: The Juilliard String Quartet has been one of the leading chamber ensembles in the US and internationally. The collection documents the quartet's domestic and international engagements between 1960 and 1967.

Creator History

The Juilliard String Quartet was founded in 1946 by William Schuman, then president of the Juilliard School, and violinist Robert Mann. During the years documented in this collection, Robert Mann served as First Violin, Isadore Cohen as Second Violin (replaced by Earl Carlyss in 1966), Raphael Hillyer as Viola, and Claus Adam as Cello. Since its inception the quartet has been one of the leading chamber ensembles in the US and internationally. In 1961 it toured extensively in Southeast Asia and Russia, returning to Japan in 1966.

Scope and Content Note

The collection primarily documents the activities of the Juilliard String Quartet during the years 1961-1962 and 1966-1967, with the bulk of materials covering 1966-1967 when Seymour Krawitz served as publicist. The collection includes letters, concert invitations and other items of correspondence to and from Mr. Krawitz. The collection documents the quartet's touring as part of the American National Theatre and Academy program in locations such as Taiwan, the Philippines, Singapore, Laos, Japan,

Australia, and New Zealand. Also included are several pages of notes from an earlier period in the mid-1950s when the ensemble was managed by Miriam E. de Kika.

b. 1 f. 1 Seymour Krawitz correspondence 1966-1967

Includes publicity requests, press releases sent by Seymour Krawitz to staff at the New York Times, the Associated Press, United Press International, the Today Show, and Seventeen Magazine, among others. Also includes letters to and from Krawitz regarding possible appearances of the quartet at the Library of Congress, the White House, and regarding recording contract with Columbia-Epic Records. Of note is a survey done by Columbia Records evaluating preference among record dealers for "Columbia" or "Columbia-Epic" as record labels.

b. 1 f. 2 Diplomatic correspondence 1960-1961

Includes letters and telegrams related to Juilliard String Quartet's international touring under the auspices of the American National Theatre and Academy. Includes correspondence between quartet, U.S. ambassadors, and local representatives regarding logistics, repertoire selection, and a data report on the quartet's successful concert series in Taiwan.

b. 1 f. 3 Clippings 1966

Includes articles from Japanese press about the Juilliard String Quartet and about their workshop held in Nikk_ entitled "One Day at Juilliard."

b. 1 f. 4 Personal Papers 1967, undated

Includes correspondence and drafts related to articles about the Juilliard String Quartet.

b. 1 f. 5 Miscellaneous files 1950-1967, undated

Includes documents from 1950s when Miriam E. de Kika managed the quartet; documentation of 1950s tours to the Netherlands and to Russia; agreements between the quartet and Columbia Records; itineraries and other logistical documents related to international touring. Also includes an advertising strategy for the quartet, likely written by Seymour Krawitz.
