# **Creator History**

The Board of Trustees, the governing body of The Library, was established in 1895 by an agreement that consolidated the Astor and Lenox Libraries and the Tilden Foundation to form The New York Public Library. Initially there were twenty-one trustees, with seven being appointed by each of the three institutions that had been merged to form The Library. Trustees had no set terms of office; they served on the Board until they resigned, died, or were removed by a vote of the other trustees. New trustees were elected by the current members of the Board. Following the consolidation of The New York Public Library and The New York Free Circulating Library in 1901, the number of trustees was expanded to twenty-five. This included three New York City officials as ex-officio members: the Mayor, the Comptroller, and the President of the Board of Alderman.

John Cadwalader, Lewis Cass Ledyard and George Lockhart Rives were the three most powerful members of the Board of Trustees during the first two decades of The New York Public Library. All three served on the original Committee on Consolidation of the Astor, Lenox and Tilden Libraries, Cadwalader as an Astor Library trustee, Ledyard as a Tilden trustee, and Rives as a Lenox Library trustee. All were on the Executive Committee and served at various times as President of the Board of Trustees. Rives served also as Secretary from 1895 to 1902.

Born at Trenton, New Jersey on November 17, 1836 to a family prominent in New Jersey and Pennsylvania, John Lambert Cadwalader received his B.A. from Princeton in 1856 and, in 1860, his LL.B from Harvard Law School. Cadwalader marked his 1869 arrival to New York by a brief association with the offices of Dorman B. Eaton and was active in founding the Association of the Bar of the City of New York. Nominated to Assistant to the U.S. Secretary of State in 1874, shortly after his term expired, Cadwalader returned to New York to form a partnership, his definitive professional alliance, with Charles E. Strong.

Inaugurating a lengthy alliance with New York's public libraries, on November 5, 1879, Cadwalader was elected a member of the Board for the Astor Library. After the consolidation of the Astor with the Lenox Library and Tilden Trust on May 23 1895, he served as a member of the NYPL executive committee until his death in 1914. Cadwalader's profound interest in art was expressed by his involvement with the Art Committee and the Advisory Committee on Prints. His legacy of service to NYPL is typified by his tenure as First Vice-President (1909-1912) and his incumbency as President from 1912-1914.

Cadwalader shouldered a vital share of the work in effecting consolidation between the Astor and Lenox Libraries and the Tilden Trust. He proved to be of particular efficacy in unraveling legal and financial problems. For example, he drafted the consolidation agreement, created compromise resolutions, and arranged with members of the New York State Assembly to have a special consolidation bill passed. Cadwalader also negotiated with the heirs of Henrietta Lenox, who retained a vital share in Library property. From December 1895, Cadwalader played a pivotal role in the site acquisition, planning and construction of the Central Building. Besides effecting key negotiations for appropriations with the city, Cadwalader lent his aesthetic sense to design considerations, including the front statuary and various inscriptions. Cadwalader is usually credited with bringing John Shaw Billings, NYPL's first Director, to The Library. Also, while instrumental in taking over the work of the Free Circulating Libraries and other smaller endeavors funded by public money, he furthered arrangements with the city upon the funds of the Carnegie Library Bill.

The creation and development of the Print Department held a keen interest for Cadwalader. His will provided a gift of his entire personal collection of 360 eighteenth-century mezzotint engravings as well as a \$50,000 bequest for print acquisitions. Reflecting another abiding concern, his will also bequeathed a sum devoted towards increases in the salaries of the Reference Department.

# **Scope and Content Note**

The Founding Members Records consist of handwritten, typewritten and printed documents and span the years 1895 to 1930. They include John Cadwalader's correspondence, 1895-1914 and his general files, 1904-1913; Lewis Cass Ledyard's correspondence, 1897-1930; and George Rives' files, 1904-1916. Items include incoming and outgoing correspondence, interoffice memoranda, NYPL Executive Board memoranda, drafts of Board of Trustee minutes, budgets, clippings, receipts, bills, and reports of various NYPL committees generated during the day-to-day operations of The Library during its early years. The records document the founding of The New York Public Library and illuminate a wide range of Library affairs, as well as the careers of its trustees and staff.

**Arrangement:** The Founding Members Records are arranged in three series: I. John L. Cadwalader, 1895-1914; II. Lewis Cass Ledyard, 1897-1930; III. George Lockhart Rives, 1904-1916.

The records of NYPL Trustee John Cadwalader consist of two subseries, described below.

Subseries A. Correspondence 1895-1914 (1 box)

Arranged chronologically by date sent. The years 1895-1909 are primarily represented by incoming correspondence, while the remaining years, 1909-1914, consist of mostly outgoing correspondence. The subseries covers such topics as the consolidation of the Astor, Tilden, and Lenox Libraries to form NYPL; NYPL's absorption of other libraries (including the Aguilar and the New York Free Circulating Libraries); early print acquisitions; and exhibitions (1911). There is abundant material regarding the NYPL Central Building competition, as well as concerning its planning and construction. From as early as 1896, explicit mention is made of the 42nd Street site. During the ensuing fifteen years correspondence concerning site acquisition, funding, planning, and construction accounts for the bulk of the subseries. Highlights include Cadwalader's penciled annotations for the final competition designs. Memoranda are represented in almost every part of the correspondence and include commentary for early exhibitions of Library materials, a draft for The Library's accession policy (1896) and discussions on the exemption of humanitarian and charitable societies from the tax on collateral inheritance. From 1900 to 1913, a discussion evolves concerning exemptions from estate and inheritance taxes for charitable institutions and possible ramifications of this repeal for The Library. Other subjects include copyright law in relation to NYPL's book importation policy and Branch Library property purchases. Notably, a heated exchange about The Library's opening hours developed in 1912, involving Cadwalader, other trustees and contemporary newspapers. Also included are papers relating to the consolidation of the Free Circulating Libraries and NYPL. The correspondence gives glimpses into Cadwalader's personal life. There are numerous notes and lists addressed to John Shaw Billings and E.H. Anderson concerning books that he decided to purchase himself. Individuals who figure prominently in the correspondence include George Rives, John Shaw Billings, Edwin Hatfield Anderson, William Allen Butler, Steven H. Olin, Charles Howland Russell, Wilberforce Eames, and Robert de Forest.

### Subseries B. Subject Files 1904-1913 (1 box)

Arranged alphabetically by topic. Correspondence, press clippings, pamphlets, programs and legal material relating to a variety of individuals, divisions, and concerns of The Library. Cadwalader's keen interest in The Library's print collection is well represented in material relating to exhibits and the Art Committee. Issues of funding and the search for a suitable music librarian attest to The Library's burgeoning Music Collection. Items include detailed explanations for the front statuary iconography for the Central Bulding (1913) and drafts for the attic statuary inscriptions (1905-1906). Cadwalader's concern with both individual employees and employee welfare is well represented. There are numerous files attesting to Cadwalader's intercession on an employee's behalf. Notably, proposals are made for cooperative employee housing (1911) and an employees' club (1911). The series is rounded out with an assortment of biographical sketches of deceased trustees for the minutes of the Executive of Trustees.
