The Edward Kleban sound recording collection consists of 9 sound recordings collected by Edward Kleban during his time spent collaborating with Marvin Hamlish on the musical "A Chorus Line". Recordings of songs written for the musical are performed either by Marvin Hamlisch and Edward Kleban or by cast members. Many of the songs are early versions, or were not included in the final production. Also included are interviews with Marvin Hamlisch, Kleban and Priscilla Lopez, and recollections of selected cast members' lives.
