The WINC directorate included W.A. Domingo, Hope R. Stevens, Charles Petioni, H.P. Osborne, Richard B. Moore, Arthur King, Ivy Bailey Essien, and Amy Ashwood Garvey. Because of their nationalist ideologies, association with radical or liberal organizations, and their anti-colonialist political position, the FBI closely scrutinized the WINC for their alleged "subversive activities in the West Indies.".
