Creator History

William Dye Smith (1880-1951) was an African American soldier who served in the Philippine-American

War (1899-1901), Pulahan Revolt (1906), Mexican Expedition (1916), and throughout the United States until his honorable discharge in 1923. Smith was initially drafted into Company B, 25th Infantry of the United States Army Quartermaster on November 30, 1898, and served in various clerical posts, including Quartermaster Clerk and Quartermaster. He later became Sergeant with the Q. M. Corps at Fort San Padre, Philippine Islands in 1914. Smith served and was stationed in a number of places in the United States, such as Arizona, New Mexico, New York, Texas, and Wyoming.

Smith was born in St. Louis, Missouri August 6th, 1880. He married Laura E. Smith and together they had six daughters: Mable, Danetta, Mildred, Manila, Edith and Winifred. Smith lost his wife in 1938 and died in 1951 in Los Angeles, California.

Scope and Content Note

The William Dye Smith papers consist primarily of correspondence relating to the family and military life of Smith and his immediate family members. Through correspondence, details of trying times, difficult conditions, and bravery are revealed. Letters give insight into an African American military family during the late 19th century and early 20th century throughout the Spanish-American War and Philippine-American War.

Series I, Family Correspondence, 1901-1946 (bulk 1916-1922), includes correspondence between William Dye Smith (WDS) and his wife Lauren E. Smith (LES), as well as correspondence to and from Smith's daughters, friends and other family members such as his cousin Mamie Casey. Correspondence includes evidence of Smith's participation as a freemason and membership with United Grand Commandery Knights Templar in Missouri.

Series II, Military Records, 1898-1931 (bulk 1916-1922) include records and correspondence of Smith's time in the United States Army. As in Series I, there is evidence of Smith's participation as a freemason and membership with United Grand Commandery Knights Templar in Missouri.

Series III, Miscellaneous Correspondence, 1898-1931 (bulk 1916-1922), includes letters from family members and friends to William Dye Smith and Laura E. Smith. The letters were essentially a way of catching them up on their lives and asking about the state of the Smith's lives.

Arrangement: Papers are organized into three series: I. Family Correspondence; II. Military Records; III. Miscellaneous Correspondence Artificial arrangement by donor. Correspondence is arranged chronologically.

Series I Boxes 1-2: Family Correspondence, (1901-1946, bulk 1916-1922), includes letters to and from William Dye Smith to his wife Laura E. Smith; to and from his daughters Mable, Manila, Danetta, Mildred, Edith and Winifred; and other family members of William Dye Smith and Laura E. Smith. Correspondence describes some of the details of military life and hardships for Smith, expected growth and frustrations with the army, his accomplishments, and the unquestionable love he had for his wife and daughters. Smith greatly missed his family during his military service and noted throughout correspondence with his wife Laura how sad he was to miss out on some of the milestones of his daughters' lives. The box includes correspondence from other family members such as George Smith (father to William), Nannie Sanders (Laura Smith's mother) and Mamie Casey (cousin to William). There is significant correspondence between William Dye Smith and his daughter Mable Smith and also relating to her passing. Mable was the eldest of the daughters and seemed to have a close relationship with her father. She died in 1923 at the age of 19. The Smiths received condolence letters and cards from family and friends after the passing of Mable. Also found in this series are letters to William and Laura from their daughters. One highlight is a letter from daughter Danetta Smith to her mother writing about the Reverend Adam Clayton Powell speaking at a dinner. There is also correspondence with friends and others regarding personal business inquiries and transactions, as well as persons that are related to military business. In addition to letters are clippings, greeting cards, invitations, menus and telegrams. Also included are the Smith's marriage announcement and license. See full folder and item inventory list.

Series II Box 3: Military Records (1898-1931, bulk 1916-1922) document William Dye Smith's military career. Included are correspondence to and from military peers and superiors, applications for business concerning family support, allowances, promotions, biographical records, exams on military regulation and topography, financial records, special orders throughout his military career, promotions received and denied, recommendations and letters of reference, documents related to reenlistment activity, and his retirement in 1923. There are also records of Smith's reporting stations in the United States such as Fort D. A. Russell, Wyoming; Columbus, New Mexico; and Mercedes, Texas; and also outside of the United States in Colonia Dublan in Mexico and Manila, Philippines.
