1774, Jan. 1.

Thomas Moncrieffe and his wife Mary to Jonathan Mallet for house and lot on Smith Street.

1774, Jan. 7

Jonathan Mallet to Thomas and Mary Moncrieffe for house and lot on Smith Street in the East Ward.

1785, Oct. 9

John Reade and his wife Catherine to Joseph Ketchum for lot on Beekman and Ann Streets in the Montgomerie Ward.

1799, Mar. 7. Isaac Clason and his wife Catherine to Johnson Patten for parcel of land at Corlears Hooks in the 7th Ward.

Jacob Schieffelin and his wife Hannah to John B. Lawrence for lots of land in the 7th Ward.

1800, Sept 30

John B. Lawrence to Jacob Schieffelin for several tracts of land in Lycoming Co., Penna. including the Rotterdam Tract, the Wilmington Tract, and the Troy Tract.

John Hooke to Jacob Schieffelin for parcel of land on the west side of Walnut St. (formerly Ferry St.) in the 7th Ward.

1805, Sept 30

John L. Waldron and his wife Elizabeth to Jacob Schieffelin for three tracts of land near Bloomington Road in the 9th Ward (with three maps by Charles Loss, surveyor).

1806, Feb. 14

George Mckay and his wife Helena to Jacob Peterson for house and lot on Mott St. in the 6th Ward.

1808, Jan 11

Abraham Baudouine to Ezekiel Robins for house and lot on Pearl St. in the 2nd Ward.

1809, Feb. 24

Thomas Buckley and his wife Anna, and John B. Lawrence and his wife Hannah N. to Jacob Schieffelin for 29 parcels of land in Manhattanville in the 9th Ward.
