## **Descriptive Summary**

**Abstract:** The archive contains material related to the publication of four novels and one unpublished novel written by Auster during the period 1999-2005; material related to the publication of volumes of collected poetry, novels, and prose published in the period 1999-2006; and material related to the genesis of five film projects: the HBO project "I Thought My Father Was God," based on Auster's collection of reminiscences published in 2001; "The Country of Last Things," based on Auster's novel published in 1987; and "Lulu on the Bridge." Also present are materials related to four nonfiction works, an illustrated fiction project ("Auggie Wren's Christmas Story," first published in 1990); contributions, prefaces, interviews from the period 2000-2005, and material related to reissues of translations completed mostly during the 1970s but published 2002-2005. Additional material includes promotional artwork; programs featuring Paul Auster; and public remarks made by Auster and those introducing him at these events. Also present is material written by others, including creative adaptations of Auster's work and scholarly analyses of his work. The archive is rich in both incoming and outgoing correspondence, and includes letters to and from writers and friends, agents and publishers, as well as translators, readers, students, and organizations.

In addition to the papers described here, the Berg Collection houses the earlier papers of Paul Auster (ca. 1972-1999), divided into two groups, each with a finding aid. The first describes papers dating from 1963 to mid-1995 (bulk 1972-mid-1995) and will be sent on request, from the Berg Collection. The second, which describes papers created in the period 1995-2000, has not been completed; upon its completion, access to those papers will be permitted.

#### **Biography**

Paul Auster is a Brooklyn-based novelist, screenplay writer, poet, essayist and translator. He is best-known for his *New York Trilogy*, a series of three loosely linked novellas published separately 1985-1986, and for his subsequent novels *Moon Palace*, *The Book of Illusions*, and *Oracle Night*. In these novels and others, Auster's protagonists, frequently writers and Brooklynites themselves, struggle to find meaning in lives set adrift by coincidence and tragedy. These themes resonate throughout Auster's fiction, nonfiction and screenwriting.

Auster was born in Newark in 1947 and grew up in the New Jersey suburbs of New York. After graduating from Columbia University, he spent four years in France, where he wrote poetry and supported himself by working as a translator. He married the writer Lydia Davis in 1974; they divorced in 1978. In 1982, Auster married writer Siri Hustvedt. That same year, he published the memoir *The Invention of Solitude*, his debut prose work. That genre-bending book, written largely about his father's sudden death, melds autobiographical narrative with meditations on memory, language, and solitude.

In 1985-86, Auster published to critical acclaim the three novellas that would form the *New York Trilogy. City of Glass, Ghosts*, and the *Locked Room* blend postmodern fiction with detective noir, and in each case, feature protagonists struggling to make sense of a series of baffling events that shake their faith in a rational world. More realistic novels with stronger narrative elements followed the *New York Trilogy*. The novels *In the Country of Last Things, Moon Palace, The Music of Chance, Mr. Vertigo* and *Leviathan* maintained the themes of loss, chance, and search for identity in Auster's earlier work.

Auster's novels Timbuktu, The Book of Illusions, Oracle Night, and The

*Brooklyn Follies* were composed and / or published in the period 1999-2005. During these years, Picador also published Auster's *Collected Poems* (2004) and *Collected Prose* (2005), while Faber and Faber printed the first volume of his *Collected Novels* (2005). Other work from this period include the illustrated *Auggie Wren's Christmas Story* (the titular protagonist is reprised from the films, for which Auster wrote the screenplays, *Smoke* and *Blue in the Face*); *The Story of My Typewriter*, an elegy for Auster's Olympia typewriter, with illustrations by Sam Messer; and the Perishable Press publication, *Reflections on a Cardboard Box*, a meditation on homelessness. Auster also worked on a number of screenplay projects during this period, including adaptations of his novel, *In The Country of Last Things* and scripts for the films *Homeland*, *Lulu on the Bridge*, and *The Monster of Longwood*.
