The Valerie Rochon Papers were donated to the Jerome Robbins Dance Division in 2001 by Valerie Rochon.

Biographical Note

Valerie Jerusha Rochon was the director of the mid-1980s African American Dance Directory Project. Rochon designed this project, which operated under support of the New York Foundation for the Arts, as a three-stage endeavor to compile a comprehensive resource that would serve as a research and marketing tool for, and regarding, African American dance companies performing modern, jazz, tap, ballet, and African Folkloric dance. Rochon also designed the directory to include commissioned essays and art work as well as maintain publication of an essay-based newsletter titled *Movements*. It appears that only one issue of *Movements* was ever published. Ultimately Rochon was unable to complete the directory as envisioned; however, a preliminary edition containing partial information was published in 1986.

Valerie Rochon's personal papers and clippings files show an interest in African-American and minority-based cultural development, arts, and politics. Valerie Rochon received her Bachelor of Arts Degree with a major in Education and Dance from Arizona State University-Tempe and followed this with additional courses towards a Master's Degree. Rochon then proceeded to find employment in a variety of arts based positions. From 1976 to 1980, she worked as a dance teacher for the Phoenix Union High School District in Phoenix Arizona. From 1980-1981, she served as Administrative Assistant for the Wajumbe Cultural Institution in San Francisco, California. In 1982, she worked as a Volunteer Coordinator for the Brooklyn Academy of Music and was responsible for communications between African American dance companies. In addition, Rochon once worked with Eno Washington in a cultural project known as the Mighty Eno Enterprises.

Even though the African American Dance Directory never came to fruition as she planned, Rochon continued to collect dance materials for the project until the year 2000. She also maintained her ties to the African American dance community. In the late 1980s, Rochon served as an artist's representative of the management agency Bess Pruit & Associates, Inc. In 1996, while she was a Dance Teacher for I. S. 90 in New York City, Rochon served as contact person for visiting dancers from the Dance Theatre of Harlem and the Fieldston Dance Company.

Scope and Content Note

The Valerie Rochon Papers primarily consists of materials related to the development of the African-American Dance Directory. Most of these materials focus on the years between 1983 and 1987. The first mailing for the project went out to companies in 1984 and the preliminary edition of the directory was published in 1986. Materials include correspondence, administrative information, financial information, source information on dance companies and supporting arts agencies, and clippings.

The collection also includes a minor amount of personal materials and a small number of clippings related to African-American and minority-based cultural development, arts, and politics.

Series Descriptions

Series I: African American Dance Directory, 1973-2000

Valerie Rochon designed the African American Dance Directory as a comprehensive resource for, and regarding, African American dance companies performing modern, jazz, tap, ballet, and African Folkloric dance. The project was supported by the New York Foundation for the Arts as well as by a grant from the National Endowment for the Arts. Rochon envisioned a directory that would equally be a dance resource and a marketing tool for the profiled companies and individual researchers. The directory was designed to contain detailed information on all African American dance companies as well as sponsors, and funding agencies. In addition, Rochon planned to commission

original essays and art for the directory. In 1985, the directory project published an edition of the newsletter *Movements*. This newsletter was to serve as an information exchange between the African American dance community and the general public through essays and listings. It does not appear than another edition was ever published. Ultimately Rochon was unable to complete the directory as envisioned; however, a preliminary edition containing partial information was published in 1986. Materials in this series correspond to all aspects of the development of the African American Dance Directory. Rochon's labels were maintained wherever possible.

Sub-series 1 - Correspondence, 1982-1989

Arrangement: Alphabetical according to date and then project.

This sub-series contains both personal and professional correspondence related to the development of the African American Dance Directory. Correspondence referencing specific agencies or companies is filed with the appropriate folder.

Sub-series 2 – Administrative Material, 1984-1986

Arrangement: Alphabetical.

This sub-series contains materials related to administration of the African American Dance Directory project. Materials include copies of form letters and questionnaires as well as project schedules and administrative reports.

Sub-series 3 - Financial, 1983-1989

Arrangement: Alphabetical.

This sub-series contains materials related to all of the financial aspects of the project. Materials include budget and accounting information as well as printing estimates and grant applications.

Sub-series 4 – Source Materials, 1973-2000

13.5 boxes

Arrangement: Alphabetical by state and project.

This sub-series contains all of the source materials collected by Valerie Rochon as she prepared the African American Dance Directory. Source materials consist of publicity materials produced by individual companies and arts agencies as well as general news clippings. Materials include advertising booklets describing the variety of arts groups operating within a state, computer printouts listing the names of dance companies, brochures detailing the annual schedule of a performing arts facility, publicity materials containing comprehensive information about individual companies, and clippings describing specific companies or dance in general. Publicity materials include company descriptions, show reviews, booking information, photographs of dancers and specific dance pieces, and photocopied articles about specific companies.

Source materials are organized under the categories: Directory Files and General Files. Directory Files contain all of the materials that Rochon filed into labeled sub-categories. General Files contain all loose source materials and clippings that Rochon did not file into sub-categories.

Categories under Directory Files include: Arts Agencies, Companies, Libraries, Presenting/Sponsoring Agencies, Publications, General Dance Organizations, and Index Cards. Arts Agencies materials consist of resources produced by state or local agencies dedicated towards promoting the arts within a specific region.

Companies folders consist of materials, mostly publicity, related to a specific company. Rochon arranged the Companies folders alphabetically by state according to a shorthand code for each dance form. The code is as follows: M-Modern, J-Jazz, T-Tap, B-Ballet, and AF-African Folkloric. Some folders include variants on this code, such as M-Post—for Post-Modern. Many of the company folders contain the appropriate completed and edited African American Dance Directory Questionnaire.

Libraries folders contain materials about libraries with arts based collections and programming. Presenting/Sponsoring Agencies contain materials related to agencies that host dance based programming. Publications folders contain publications that publish dance related articles.

General Dance Organizations contains materials that Rochon filed without further arranging into specific sub-categories. Index Cards contains materials that Rochon arranged into groupings of company data. Most materials are arranged alphabetically according to state.

Sub-series 5 – Directory, 1984-1986

1 box

Arrangement: Alphabetical.

This sub-series contains materials directly related to the published form of the directory. Materials include completed questionnaires, edited directory drafts, and inscribed preliminary editions as well as a copy of the newsletter *Movements*.

Series II: Personal Materials, 1978-1996

1.5 boxes

Arrangement: Alphabetical.

This series contains materials unrelated to the African American Dance Directory. Materials include personal correspondence, an early resume, and a headshot as well as information related to Valerie Rochon's working relationship with Eno Washington. Materials also include loose clippings and a scrapbook primarily focused on African American cultural, political issues and apartheid. The scrapbook materials were housed in a 1976 published blank book titled *The Nothing Book*.
