Scope and content note

The collection includes ca. 750 original designs, primarily costume designs, but also set designs, photographs, blueprints, and set model pieces by Carl Michel, for over 50 ballets and 8 theater productions. Many of the designs are for works by Dance Theatre of Harlem from 1973 to 1995. Their stage and television productions of *Giselle* (1984 and 1987) are especially well-documented and include Michel's extensive research papers, in addition to his costume and set designs, and set models. *The Joplin Dances* (Dance Theatre of Harlem, 1995) and various productions of *The Nutcracker* and *Swan Lake* are also well-represented. There are also numerous costume designs for Hartford Ballet Company productions.

Theater productions for which Michel designed costumes include *The Boy Friend* (1964); *An Evening with Sweeney* (1969); *The Great Gatsby* (musical, Yale Dramat, 1956); *The Merry Wives of Windsor* (his first-produced costumes; Yale University Drama Department and NBC's *Omnibus*, 1953); *Story Theatre* (Yale Repertory Theatre and WNET-TV, 1969); and *The Taming of the Shrew* (Richmond Shakespeare Festival, 1969). Costume designs for *The Country Wife* (1951) were never executed.

Dancers for whom Michel designed include Mikhail Baryshnikov, Erik Bruhn, Gelsey Kirkland, Patricia McBride, Peter Martins, Natalia Makarova, Violette Verdy, Edward Villella, and other performers such as opera singers Galina Vishnevskaya and Klara Barlow.

In addition to his costume designs, the collection includes Michel's set designs for Dance Theatre of Harlem's productions of the ballets *Concerto in F* (1986), *Fête Noire* (1989), *Giselle* (stage version 1984, television version, 1987); *Mirage* (1986); *Pas de Dix* (1983); *Prince Igor (Polovetsian Dances)* (1988), and *Swan Lake*, Act II (1989.

Almost all designs are signed and dated. Some costume designs and a few set designs were never executed and are marked as such. Some of the photos show Carl Michel designs for which there are no sketches in the collection. Of particular interest is a photograph showing Carl Michel fitting Mikhail Baryshnikov in his Act II costume for his first U.S. *Giselle* (ca. 1975) and a genealogy chart for Giselle in the research papers for Dance Theatre of Harlem's stage production (1983).

Note: Due to their fragility, Set Model pieces (Boxes 14, 15, 18, 19) may viewed by appointment only.

Biographical Note

Costume and set designer Carl Michna Michel was born April 3, 1928. A former resident of Canyon, Texas, he was a graduate of Yale University School of Drama and also studied in Europe. Michel designed and executed costumes for theatre productions, later gravitating to designing costumes almost exclusively for the ballet. He designed costumes for some 17 ballets for Dance Theatre of Harlem from 1973 to 1990, also designing sets for a number of them; Michel also co-authored (with Arthur Mitchell) the scenario for the company's production of *Giselle* (1984). He became production supervisor for Dance Theatre of Harlem in 1985. Michel designed costumes for over 15 other ballet companies and was a member of the International Brotherhood of Painters and Allied Trades and United Scenic Artists. He died Nov. 12, 2004.
