Abstract: Donald S. Harrington, 1914-2005, was the Minister of the Community Church of New York, a Unitarian Universalist congregation, from 1944-1982. He also served as president of the United World Federalists, and as chairman of the Liberal Party of New York, 1966-1982. His papers consist of correspondence, sermons and other writings, topical files, estate and financial papers, and miscellaneous printed material reflecting Harrington's religious and political activities.

Creator history

Donald S. Harrington, 1914-2005, was the Minister of the Community Church of New York, a Unitarian Universalist congregation, from 1944-1982. He was born July 11, 1914 in Newton, Massachusetts and graduated from the University of Chicago. He was ordained in 1939, serving his first church, the People's Liberal Church on Chicago's South Side.

In 1939 he married fellow seminary student, Vilma Szantho. It was said that Vilma was the first woman ordained in Central Europe. The couple had two children; David, of Santa Fe, NM and Loni Hancock. Vilma died in 1982. Harrington remarried in 1984 to Aniko Szantho, Vilma's niece. Aniko was also an ordained Unitarian minister.

Harrington was among the founders of the American Committee for Africa, and was an early opponent of the Vietnam War. But he is also known for his ties to the Liberal Party of New York.

Through his involvement with the Liberal Party, he came in contact with many prominent politicians, including: John V. Lindsay, Charles E. Goodell, Jacob K. Javits, Hugh L. Carey and Mario M. Cuomo. In 1966 he was Frankin D. Roosevelt Jr.'s running mate for governor. In 1970 he briefly ran for Governor on the Liberal Party ticket, but deferred to the Democrat canidate, Arthur J. Goldberg. He was the Chairman of the Liberal Party, 1966-1982.

He was also the President of the United World Federalists. The movement brings together organizations and individuals which support the establishment of a global federal system. Many global institutions with plenary constitutional power would then be accountable to the citizens of the world. With international authority divided among these separate global agencies.

Harrington died September 16, 2005 in Romania, where he had been living.

Scope and content note

The collection consists of correspondence, estate and financial papers, and miscellaneous printed material reflecting Harrington's religious and political activities. General correspondence, 1936-1989, contains information concerning religious matters including the Community Church of New York and the Unitarian Universalist Association; and political affairs such as Harrington's work with the United World Federalists, the Liberal Party of New York and the New York State Constitutional Convention of 1967. Handwritten and typescript copies of his sermons are present along with the research materials used in their creation. Sermon topics include war, politics, poverty, segregation and race relations, sexuality/gender issues, and nuclear arms. The collection also contains estate and financial papers, and miscellaneous printed material including a topical file of print and near-print ephemera.

Series II: Sermons, 1939-1982

Sermons preached by Donald Harrington, 1939-1982. Each folder contains hand-written copy and typed copy of scripts, notes used in preparation of writing and the church service bulletin. Sermons do not follow the common lectionary.

Sermons from 1939-1949 have the following topics: fear, revolution, Hitler, prayer, poisonous gas, democracy, children, war, the Bible, marriage, R. Tagore, materialism, science and religion, India, Europe and Russia, Japan, free enterprise, education, nuclear bombs, socialized medicine, the Soviet Union, FDR memorial, social security, atomic age, labor unions and pacifists.

Sermons from 1950-1959 have the following topics: economic crisis, Israel, China, prayer, money, motherhood, race relations, Passover, changing sex roles, bombs, salvation, Soviet Union, xxThe Seven Story Mountainxx, sin, Eisenhower, the Cold War, the United Nations, taoism, welfare state, alcholism, Buddism, communists, Korea, mental health, Eastern religion, science and religion, creation, truth, Bible, raditation, peace, marriage, freedom, racial integration, India, the Dead Sea Scrolls, forgiveness, Suez crisis, liberals, Pope Pius XII, American Indians, and Soviet/American relations.

Sermons from 1960-1969 include the following topics: New York State Constitutional Convention, seperation of church and state, hippies, Martin Luther King Jr. memorial service, Israel, Robert F. Kennedy, god vs. evil, the Cold War, Black Power, love and marriage, The Great Society, judgement and forgiveness, sex, urbanization, freedom and responsibility, abortion, the John Birch Society, Parents Without Partners, Ralph Waldo Emerson, Bob Dylan and Folk Music, the Cuban Crisis, Tagore, Berlin Crisis, science and religion, Wm. Shakespere, moral dilemas, American Jews, being born again, Vatican Council, prayer, salvation, Red China and the United Nations, faith vs. belief, Channukah, peace, Albert Schweitzer, Buddism.

Sermons from 1970-1979 deal with the following topics: friendship, letter writing, democracy, sin, racial integration, American Indians, Japan, China, Korea, Israel, women's liberation, World Peace, United Nations support, elections, Vietnam, homosexuality, good vs. evil, President Nixon and Watergate, President Nixon and detente, God within, racism, saving New York City, meditation, the world economy, religion and science, freedom and morality, death, South Africa, Bible, Black Spirituality, trade unions, Black History, American Indians, Rev. Jim Jones, World Peace.

Sermons from 1980-1984 topics include: liberal religion, Olympics, born again, American Indian, prayer, Moral Crisis, Blacks and other minorities, freedom, peace, Black achievement, election, resurrection, nuclear holocaust, Church vs. State, Central America.

Lectures were given at both political and church-related functions, in addition to addresses made at college campuses. Essays were submitted for publication to various places. Manuscripts are included of books that were proposed to be published. It is unclear whether they were published or not. Book reviews were submitted to various church-related publications. Notes for classes taught are also a part of this series.

Series IV: Topical files, circa 1980-1982

Topical files of things that interested Harrington. Mostly clippings from newspapers, with portions of text underlined with comments. There are also brochures, pamphlets and various other memorabilia. As an example here is a brief list of some topics: John Stienbeck, sterilization, Starr King School, Space Shuttle, students, Sugar Act Amendments, 1971 (South Africa), summer, the Supreme Court. The topics vary widely.

Series VI: Miscellaneous material, 1948-2000

This includes the following: financial material, estate information, photographs, printed material from various organizations, various correspondence, lawsuits and court cases that Harrington was involved with, information about the Community Church, Unitarian Universalist Association and the World Federalists Association.

The financial material contains bank account information, insurance, stock purchases and retirement accounts and income tax returns. The estate information of Vilma S. Harrington, who died in 1982, contains bank accounts, medical information, income tax returns and correspondence with lawyers. There is also estate information of non-family members. Many parishioners in Harrington's church named him as their executor.

Harrington was also involved in various law suits over the years and some of this material is included. In some of these cases Harrington is a defendant, in others, he is a witness.

Both the Community Church and UUA material concerns information about those organizations. It is mostly published newsletters, magazines, bulletins and other material used in the running of the organizations.
