Description: The League, which was founded in New York City in 1942 by Roger Nash Baldwin and

others, is a non-governmental organization accredited to the United Nations which is dedicated to the promotion and protection of human rights as defined in the Universal Declaration of Human Rights and other international covenants. The records include general correspondence and papers of the League's principal officers arranged into country and name/subject files; administrative records; and printed ephemera. Included are case sheets of the League's Human Rights Defenders Project and case files of its

Family Reunification Program.

HISTORICAL NOTE

The International League for Human Rights, a non-governmental organization accredited to the United Nations and dedicated to the promotion and protection of human rights, was founded in New York City in 1942 by Roger Nash Baldwin and others including Henri Laugier of France. The founders intended to create a citizens league modeled after one which had flourished earlier in France and which had been abolished during World War II. The League's original title, International League for the Rights of Man (similar to its French counterpart) was changed in 1976. Accredited also to the Council of Europe, the International Labor Organization, and the Organization of American States, the League has sought to enforce compliance by the world's governments with the human rights enumerated in the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights, and the Helsinki Final Act.

In collaboration with its foreign affiliates and other human rights groups the League has endeavored to expose and to redress specific cases of human rights abuses by repressive governments involving mistreatment of prisoners, torture, "disappearances", genocide, and political, racial and religious discrimination. Its Human Rights Defenders Project begun in 1982 has focused on defending human rights advocates who have been persecuted by their governments for their defense of human rights. In 1977, as a result of increasing demand, the League began its Family Reunification Program designed to aid persons who were prevented by their governments from emigrating to join family members living abroad, in violation of the Helsinki Final Act.

At its headquarters at 432 Park Avenue in New York City the League continues to carry on its mission of aiding distressed victims of human rights abuses, of negotiating and intervening with governments and international bodies on their behalf, of mustering public support for human rights and serving as a provider of advice, resources and publicity to affiliated human rights groups throughout the world.

The League publishes (irregularly) *Human Rights Bulletin* and has issued numerous special reports on human rights violations.

In addition to Roger Baldwin, the League's principal officers (executive secretaries, presidents, and chairmen) have included (in alphabetical order) Maureen Berman, John Carey, Roberta Cohen, Felice D. Gaer, Frances R. Grant, Herschel Halbert, Donald F. Keys, Jan Papanek, John Pearmain, Jerome Shestack, and Frieda Zimmerman.

NOTE ON PROVENANCE

The League has donated the records to the Library in a succession of gifts beginning in 1964 and continuing through the years 1967, 1975, 1977, 1981, and 1995.

NOTE ON RESTRICTIONS

In order to protect the privacy of individual persons the case files of the Family Reunification Program in Series IV. Additional Records (Containers #69-83); and a few other records (in Container #123) have been restricted until the year 2025.

ARRANGEMENT NOTE

The records are arranged into four series: I. General Correspondence; II. Administrative File; III. Printed Ephemera; and IV. Additional Records. Series IV. is arranged into four sub-series: A. Records Received in 1975; B. Records Received in 1977; C. Records Received in 1981; and D. Records Received in 1995. The series and sub-series are described in sequence below.

SERIES DESCRIPTIONS

Series I. General Correspondence (Containers #1-9)

The General Correspondence, which is arranged alphabetically into a country file and a name/subject file, falls in the period 1945-63 (bulking in the 1950's). A partial listing of correspondents in this series appears on pages 24-31 of this inventory.

The bulk of the correspondence is that of the League's chairman, Roger Baldwin, although there is also some correspondence of its secretary, Frances R. Grant, and its executive secretaries, John Pearmain and Frieda Zimmerman. Most of the correspondence is with affiliates and cooperating organizations in foreign countries and with consultants and representatives who reported on the status of human rights in foreign countries. Some of the correspondence is in French and German.

The country file contains substantial correspondence (20 items or more) relating to the following countries: Austria, Cameroon, Cyprus, Ethiopia, France, Germany, Ghana, Haiti, Hungary, India, Iran, Japan, Liberia, Morocco, Nigeria, Poland, Ruanda-Urundi, South Africa, Spain, and Togoland.

The name/subject file contains substantial correspondence (20 items or more) with following persons and organizations: American Committee on Africa, The Anti-Slavery Society, The Ethical Union, Gertrude Baer, Max Beer, Julio Alvarez Del Vayo, Clifford Forster, Jesus de Galindez (including correspondence relating to his disappearance), Frances R. Grant, Donald S. Harrington, International Court of Justice (The Hague), Ligue für Menschenrechte (Austria), André de Maday, Boris Mirkine-Guetzévitch, Movement for Colonial Freedom, Rev. Michael Scott, United Nations, and World Federation of United Nations Associations.

Series II. Administrative File (Containers #9-11)

The Administrative File which is arranged topically relates to the League's internal administration. Included are correspondence (1948-60) relative to the advisory committee and the board of directors; minutes (1952-57) of the board of directors; correspondence (1948-56) relating to prospective affiliates; correspondence (1949-59) with consultants and representatives abroad; press releases (1948-55); and other records.

Series III. Printed Ephemera (Container #12).

The printed ephemera consists of a name/subject file of ephemera which is collateral to the general correspondence in Series I. The ephemera is listed on page 12 of this inventory.

Series IV. Additional Records (Containers #13-123)

A. Records Received in 1975 (Containers #13-33)

These additional records consist of general correspondence arranged into a country file and a name/subject file. The correspondence falls in the period c1954-74 (bulking in the 1960's). Officers corresponding for the League include Roger Baldwin, chairman and honorary president, Roberta Cohen (executive director), Donald F. Keys (executive director), and Jan Papanek (chairman). Some of the correspondence is in French and German.

The country file contains substantial correspondence (100 items or more) relating to the following countries: Austria, Canada, Cuba, England, Egypt, France, German Democratic Republic, Federal Republic of Germany, Haiti, India, Indonesia, Iran, Israel, Jamaica, Japan, Korea, Mexico, Morocco, Portugal, Puerto Rico, South Africa, Spain, Switzerland, and Taiwan.

The name/subject file contains substantial correspondence with the following organizations: African Society for Human Dignity, Amnesty International, Baha'i International Community, Belgium League for the Defense of the Rights of Man, International Commission of Jurists, International Federation for the Rights of Man.

B. Records Received in 1977 (Containers #34-38)

These additional records consist of correspondence (1956-74) and printed ephemera relating to Greece, Paraguay, and the United States. They supplement the records in sub-series A. Officers corresponding for the League include Roger Baldwin, John Carey (chairman), and Herschel Halbert (executive director).

The Paraguay file contains a copy of a doctoral dissertation (in French) by François Chartrain relating to political parties and the Church in Paraguay since independence. The United States file contains correspondence and printed matter relating to the war in Vietnam.

C. Records Received in 1981 (Containers #39-48)

These additional records consist of a topical file of correspondence and papers in the period 1957-79 (bulking in the mid-1960's - early 1970's). Officers corresponding for the League include Roger Baldwin, John Carey, Roberta Cohen, Herschel Halbert, Donald F. Keys, Jan Papanek, and Freida Zimmerman.

Included are correspondence and papers relating to the following: the planning of the International Year for Human Rights (1968) in celebration of the 20th anniversary of the United Nations' Universal Declaration of Human Rights; the (World) Assembly for Human Rights held at Montreal, Canada (1968); Herschel Halbert's chairmanship of the Ad Hoc Committee on Human Rights and Genocide Treaties; conferences and seminars on human rights sponsored by the United Nations and other organizations; the American Jewish Committee, the Council of Europe, and the International Labor Office. Included also are correspondence and papers relating to the League's draft statement on Vietnam ("Human Rights in Vietnam"); and a typescript draft of a study on Vietnam ("Settlement in Vietnam: The Protection of Human Rights") prepared for the League by Mark A. Lothrop.

D. Records Received in 1995 (Containers #49-123)

These additional records are arranged into four sub-series:

- 1. General Correspondence and Papers;
- 2. Administrative File;
- 3. Family Reunification Project;
- 4. Printed Ephemera; and
- 5. Miscellaneous Restricted Records. In order to protect the identity of individual persons a few records have been removed to sub-series 5. Miscellaneous Restricted Records. Also, the case files in the Family Reunification Project have been restricted until 2025.

The sub-series are described in sequence below.

1. The General Correspondence and Papers which fall in the period 1954-1990 (bulking in the mid-1970's-mid-1980's), are arranged alphabetically by country. Officers corresponding for the League include Roger Baldwin, Maureen R. Berman, Roberta Cohen, Felice D. Gaer, Donald F. Keys, Jerome Shestack,

and Frieda Zimmerman. Some of the correspondence and papers are in foreign languages including French, German, and Spanish.

The papers relate to a broad range human rights abuses in Europe, the Caribbean, Central and South America, and to a lesser extent, in Africa and Asia. Included is correspondence with governmental officials, representatives of diplomatic missions to the United Nations, with human rights organizations in America and abroad and with League affiliates and its personal representatives in foreign countries. Included are case sheets which record specific cases of human rights abuses and actions taken by the League to redress them. Some of the case sheets were prepared by the League's Human Rights Defenders Project which focused on aiding human rights advocates in foreign countries who were persecuted by their governments for their defense of human rights.

The file relating to El Salvador includes a "Report on Human Rights in El Salvador / A Report to the Board of the American Civil Liberties Union" (Jan. 1982) including notes, rough drafts and the final published report.

The file relating to Mexico includes a "Report of the Commission of Inquiry to Mexico" [sic] including lists of Mexican prisoners interviewed and their handwritten testimonies in Spanish. The handwritten testimonies in Spanish have been filed in sub-series 5. (Miscellaneous Restricted Records).

The file relating to Spain includes correspondence with the League's representative (Betty Luissier) relating to the trial of the "Carabanchel Ten", the repression of the trade union movement, and political prisoners.

The file relating to the U.S.S.R. includes papers (1970-72) relative to the founding of the Moscow Human Rights Committee (a League affiliate) founded by Andrei Sakharov; a report by Sam Dash of his trip to the Soviet Union; and typed transcripts of phone conversations between officials of the League in New York and Valeriy Chalidze in Moscow.

- 2. The Administrative File, which is arranged topically, includes papers relating to the establishment of the Human Rights Defenders Project; papers relating to Andrei Sakharov; and a mass of notes and drafts on "Disappearances" in preparation (most likely) for League testimony (Sept. 1979) on human rights abuses in Latin America before the Sub-Committee on Human Rights and International Organizations of the House Committee on Foreign Affairs.
- 3. The Family Reunification Program which began in 1976 sought to aid those who were arbitrarily denied permission to emigrate. The records consist of an administrative file and case files. (As noted above the case files are restricted until 2025).

The bulk of the administrative file consists of background information and other papers relating to the German Democratic Republic and to Romania. Included also are lists of cases, form letters, notes, and ephemera relating to congressional hearings and debates.

The case files are arranged alphabetically by country, and numerically by code number within the country. The bulk of the cases originate from persons residing in Romania and in the Federal Republic of Germany who requested the League's aid in helping themselves or their relatives to emigrate to the Federal Republic of Germany, and to other countries including Holland, Mexico, and the U.S.A. (Many of the requests were channeled through the League's affiliate in the Federal Republic of Germany). The case sheets contain the name, address and profession of the aggrieved person, the name and address of the complainant acting on his behalf, and a summary of the case including actions taken by the League. Attached to the case sheets are collateral records including correspondence with the complainant and the aggrieved person, with officials of foreign diplomatic missions, the Department of State, and Members of Congress. Some of the records are in German, Romanian, and French languages. Many of the principal

documents have been synopsized in English.

- 4. The Printed Ephemera is arranged by country (or region). Included are flyers, bulletins, handbills and other ephemera issued by human rights organizations and League affiliates in foreign countries.
- 5. The Miscellaneous Restricted Records which have been sealed until the year 2025 in order to protect the identity of individual persons, were withdrawn from the General Correspondence and Papers in subseries 1. from files relating to Bolivia, Czechoslovakia, Mexico, and the United States.
