of the Burroughs Adding Machine Company from 1920 to 1943. The

collection is composed of correspondence concerning his

genealogical research on the Standish, Backus, Curtis, Boyer and other families as well as the data and family documents he

assembled including letters, deeds, printed ephemera, photograph

albums, ancestral charts, and family crests. Also present is an illustrated European travel journal kept by Standish Backus, 1890-

1891.

Provenance note

This collection was originally donated to the New York Genealogical and Biographical Society by Virginia Vanocur, daughter of Standish Backus, in 1994.

Biographical note

Standish Backus (1875-1943) was a corporate lawyer and president of the Burroughs Adding Machine Company from 1920 to 1943. He was born in Detroit, Michigan on January 12, 1875, the only son of Charles Kellogg Backus and Eva (Standish) Backus, a descendant of Myles Standish. He married Lotta E. Boyer, daughter of Joseph Boyer, his predecessor as president of Burroughs, on January 16, 1907. Backus was a member of several clubs, including the Grolier Club of New York City and the Olympia Skating Club of Detroit. He died of a heart attack on July 14, 1943 in White Plains, New York.

Scope and content note

The collection consists of correspondence concerning Backus's genealogical research on the Standish, Backus, and related families as well as the data and family documents he assembled. The documents include letters from John Dana Standish, Backus' maternal grandfather, to his future wife Emma Darrow, deeds for land purchased by Samuel Standish, Backus' maternal grandfather, a military appointment for Cyrus Backus, his paternal grandfather, the draft of an essay written by his father, Charles Kellogg Backus, entitled "The Trees in the Church," and his own travel journal kept during a trip to Europe in 1890. Four family photograph albums contain 19th century carte-de-visite and tintype portraits.
