Abstract: Russell and Volkening is one of New York's oldest literary agencies, opened in 1940 by Diarmuid Russell and Henry Volkening. They represented some of the most noted writers in the history of American publishing, including Eudora Welty, Bernard Malamud, Anne Tyler, George Plimpton, Barbara Tuchman, Saul Bellow, Ann Petry, A. J. Liebling, and Nadine Gordimer. Included in the collection are business correspondence; financial material; inventories and submission records of manuscripts submitted to the agency and through the agency to publishers and others; some manuscripts; and other material regarding the business of the agency. The bulk of the collection is represented by correspondence between Diarmuid Russell, Henry Volkening, Timothy Seldes, and other agents and their clients, notably Eudora Welty, Barbara Tuchman, Mavis Gallant, May Sarton, George Plimpton, Anne Petry, Wright Morris, and many others.

Creator History

Russell and Volkening is one of New York's oldest literary agencies, opened in 1940 by Diarmuid Russell and Henry Volkening. They represented some of the most noted writers in the history of American publishing, including Eudora Welty, Bernard Malamud, Anne Tyler, George Plimpton, Barbara Tuchman, Saul Bellow, Ann Petry, A. J. Liebling, and Nadine Gordimer. In 1972, they sold their agency to Timothy Seldes, formerly the managing editor of Doubleday, vice president of Macmillan, and assistant publisher of *The New York Post*.

Diarmuid Russell was born in Dublin, Ireland in 1902. He was the son of George (AE) Russell, who, among other things, was the editor of *The Irish Homestead*, with James Joyce, and, later, of *The Irish Statesman*. Diarmuid worked at *The Irish Statesman* as editorial assistant for three years after his graduation from The Royal College of Science, Dublin in 1925. In 1929 he emigrated to the United States and worked in a number of cities and in different fields before moving to New York City in 1935 to accept a position in the editorial department at G. P. Putnam. He enjoyed his work at Putnam until he realized that publishers were interested more in making money for themselves than for the author. Maxwell Perkins had for many years been trying to convince Russell to open a literary agency with Henry Volkening. In 1940, Russell left Putnam and took Perkins' advice. Russell died in 1973.

Henry Volkening was born in 1902 in Jersey City, New Jersey. He graduated from Princeton in 1923. He received master's degrees in literature from Harvard University and in law from Fordham University. He was an instructor in English at New York University before he left to form the agency with Russell in 1940. Volkening died in 1972.

As of 2010, Russell and Volkening is still representing some of America's best authors. With a backlist filled with such canonized talents as Eudora Welty, Bernard Malamud, Ann Petry, A.J. Liebling and Barbara Tuchman and a front list that includes Anne Tyler, Annie Dillard, Nadine Gordimer and Jim Lehrer, among many others, they championed a diversity of authors writing across genres. Seldes, current (and long running) head of the agency, has been in the business for over fifty years and is well known throughout the industry. They handle fiction, non-fiction, and children's books, focusing on quality of writing and literary merit across the board.

Custodial History

This collection was purchased from Glenn Horowitz Bookseller, Inc. The Manuscripts and Archives Division purchased the bulk of the collection after the following material had been removed: Saul Bellow correspondence was sold to the University of Chicago; Annie Dillard correspondence was sold to Yale University; Nadine Gordimer correspondence was sold to the Lilly Library; M. F. K. Fisher correspondence was sold to a private collector; and the Bernard Malamud correspondence was separated for sale and was not part of the material acquired by the Manuscripts and Archives Division.

Scope and Content Note

This collection contains the business records of one of New York's oldest literary agencies, Russell and Volkening. Included in the collection are business correspondence; financial material; inventories and submission records of manuscripts submitted to the agency and through the agency to publishers and others; some manuscripts; and other material regarding the business of the agency. The bulk of the collection is represented by correspondence between Diarmuid Russell, Henry Volkening, Timothy Seldes, and other agents and their clients, who included Eudora Welty, Barbara Tuchman, Mavis Gallant, May Sarton, George Plimpton, Anne Petry, Wright Morris, and many others.

Author files make up more than half the records and contain rich correspondence with authors and publishers as well as other materials such as contracts and earnings statements. Highlights include over 600 letters by Eudora Welty spanning almost 50 years; over 200 letters from Barbara Tuchman; large files on Anne Tyler, George Plimpton, and May Sarton; and significant correspondence files with figures such as Reynolds Price, Peter Taylor, Jean Stafford, Peter Davison, A. J. Liebling, Maxine Kumin, and Mavis Gallant. Russell and Volkening shared close relationships with many of their writers, and their correspondence often includes long discussions of work and progress and life matters.

Correspondence with agents, editors, and publishers consists primarily of cover letters for submissions, publishers' responses to submissions, and discussions of subsidiary rights and foreign publications. This material documents the day-to-day business of the agency. Included in the material from the early days of the agency is extensive correspondence with A. M. Heath, the agency's British subagent, which includes lengthy discussions of the foreign publication prospects of particular authors and works.

While Russell and Volkening opened in 1940, the bulk of the correspondence dates from 1959. There are manuscript cards and ledgers dating from 1940 on which document the early business of the agency, but the collection contains very little correspondence with authors from that time.

Correspondence with Russell and Volkening clients Saul Bellow, Annie Dillard, Nadine Gordimer, and Bernard Malamud is not included in this collection and only limited correspondence is available for M. F. K. Fisher (see note below in Series I.A.). However, the manuscript files (Series IV) do contain records of transactions relating to these authors. This series contains files on authors represented by the Russell and Volkening agency and authors requesting representation. There are two subseries: Chronological files and Alphabetical files. This series contains correspondence between agents and authors and correspondence between agents, publishers, and others regarding the publication, editing, and reviews of works; requests for permission to republish works; correspondence regarding foreign rights; clippings and reviews; royalty statements; contracts; book covers; notes on conversations and about editing of works; manuscript cards (cards recording where and when stories were sent and whether they were purchased or returned to Russell and Volkening); typescripts, some with notes and corrections; and other material.

Russell and Volkening generally separated their correspondence with their clients from correspondence conducting business on behalf of their clients. Russell and Volkening's correspondence with publishers, periodicals, and other parties, dating from 1940 to 1972, can be found in Series III. Timothy Seldes changed this method and, after 1972, all material regarding clients is filed together.

1. A. Chronological files 1941-1945, 1951, 1954-1972 (38 boxes)

This subseries contains correspondence between Diarmuid Russell, Henry Volkening, and their clients. The correspondence is filed chronologically by year and is alphabetical by author's last name within each year. This subseries represents the early work of the agency and shows how Russell and Volkening worked with their clients and were friends with many of them. The majority of the correspondence concerns manuscripts submitted by the clients, reports to the clients on the work of the agency on their behalf, and letters accompanying royalty and other payments, but there is personal correspondence throughout the subseries.

Included in this subseries is correspondence with Peter Bogdanovich, Maeve Brennan, William Gage, Mavis Gallant, Lester Goran, Henry Beetle Hough, Leopold Infeld, Dan Jacobson, Virginia Johnson, Sue Kaufman, Thomas H. Lineaweaver III, Hugh MacLennan, Alan Marcus, Ralph Moody, Paul Moor, Marianne Moore, Raylyn Moore, Wright Morris, George Panetta, Ernst Pawel, Ann Petry, George Plimpton, Eliot Porter, George Logan Price, Thomas Pynchon, Chaim Raphael, Mary Carter Roberts, Philip Roth, Nancy Rutledge, May Sarton, Ken Shiflet, Frederick Shroyer, Howard Singer, May Natalie Tabak, Barbara Tuchman, Rexford G. Tugwell, Edward Wagenknecht, David Wagoner, David Walker, Eudora Welty, and Greer Williams. Although most of the correspondence between the agency and M.F.K. Fisher is in the hands of a private collector (see Custodial history note), correspondence between the food writer and her editors is available for 1971 (see box 34).

Russell and Volkening's correspondence with publishers, periodicals, film companies, television companies, agencies, and others, dating from 1940 to 1972, can be found in Series III.

I. B. Alphabetical files 1943-2008 (205 boxes, 3 oversized folders, and 1 volume)

This subseries contains client files arranged in alphabetical order and represents the bulk of the collection. This subseries is divided into two sections: Main files and Miscellaneous files.

The Main files appear to be the general files for the entire agency. When an agent's files became too large or beyond a certain date, they seem to have added their client files to the main author file. These files contain correspondence between agents and authors; correspondence between agents and publishers, periodicals, and others on behalf of authors; royalty statements and other financial material; requests for permission to republish works; correspondence regarding foreign rights; clippings and reviews; contracts; book covers; notes on conversations and about editing of works; manuscript cards (cards recording where and when stories were sent and whether they were returned or purchased); typescripts, some with notes and corrections; and other material.

The Miscellaneous files contain later correspondence with authors requesting representation from Russell and Volkening and small client files.

While this subseries contains some material dating from the tenure of Diarmuid Russell and Henry Volkening, the bulk of the material dates from Timothy Seldes' purchase of the company in 1972. The correspondence dating from 1972 on is mainly of a professional nature. While agents and authors still maintained close relationships, the later correspondence tends to be more professional than personal in nature.

Series II. Agent files 1961-2007 (63 boxes)

This series contains the files of Russell and Volkening agents Miriam Altshuler, Jennie Dunham, Gina Maccoby, Joe Regal, Timothy Seldes, and Harriet Wasserman. The bulk of the series is Seldes' files. The material in Series I and Series II is quite similar, the only difference being that multiple agents can be found in one box (sometimes one folder) in Series I, while the material in Series II mainly contains correspondence only with one agent and his/her clients. These files seem to have been kept in the agent's office until he/she determined they were too large or obsolete and then added them to the general author files for the entire agency.

The series contains correspondence between agents and authors and between agents, publishers, and others regarding the publication, editing, and reviews of works; requests for permission to republish works; correspondence regarding foreign rights; clippings and reviews; royalty statements; contracts; book covers; notes on conversations and about editing of works; manuscript cards (cards recording where and when stories were sent and whether they were returned or purchased); typescripts, some with notes and corrections; and other material.

Material that dates before or after the career of an agent at Russell and Volkening concerns royalties, copyrights, and other information for titles and/or clients who were represented by Russell and Volkening at one time. For example, Miriam Altshuler was an agent between 1982-1994, but the material in her files dates on either side of that time. Some clients chose to follow an agent when he/she left the agency, but some of their titles were still managed by Russell and Volkening.

However, the Legal agreements subseries includes a small amount of correspondence with authors.

III. A. Firms 1959-1971 (21 boxes)

This subseries contains correspondence between Russell and Volkening and publishers, periodicals, film companies, and television companies. The correspondence is arranged first in chronological order by year and then in alphabetical order by the name of the firm. Included here is correspondence with publishing houses such as Houghton, Mifflin and Company, G. P. Putnam & Co., and Charles Scribner and Company and periodicals such as *The Atlantic Monthly*, *The Nation*, *The New Yorker*, *Playboy*, and *Redbook*.

This subseries does not contain files for 1967 to 1969.

Researchers should be aware that Russell and Volkening filed some material under the surname in some corporate names. Correspondence with George Allen & Unwin may be found under "A", G. P. Putnam & Co. under "P", Charles Scribner and Company under "S", and so on.

III. D. Legal agreements 1940-1972 (6 boxes)

This subseries contains correspondence with publishers, periodicals, agencies, authors, and various parties seeking permission to use authors' works. The files primarily document the processes and challenges related to managing copyright, though other subjects, such as authors' contracts, are also discussed. Rights under discussion include foreign, film, reproduction, serial, and performance rights. The files contain letters clarifying or canceling existing agreements, and confirming or discussing terms of new agreements. In a few instances, legal documents are attached to letters, but in general the files do not contain copies of contracts. Statements of payment are interspersed with the correspondence. Included in this subseries is correspondence about or with authors such as Henrietta Buckmaster, Elizabeth Enright, Dan Jacobson, George Panetta, Ann Petry, and Edward Wagenknecht.

The files are arranged alphabetically by year, though some files include related correspondence from previous calendar years. There is no file for 1971. Material from the 1950s and 1960s is best-represented. Most correspondence is alphabetized by the name of the author it relates to, though a small amount of material is alphabetized by subject. For example, a report on recommended terms for television movie adaptation agreements is filed under "TV". Letters concerning multiple authors are filed by correspondent.

Series IV. Manuscript files 1940-1994 (30 boxes)

This series is divided into three subseries: Agreement summary books; Author contract cards; and Manuscript files. These files contain information about manuscripts received by Russell and Volkening, publishers and periodicals to whom the manuscripts were sent, and incomes paid to authors for the manuscripts that were sold. This series documents how manuscripts were tracked within the agency, from the assignment of a number in the manuscript registers to the number of publishers and periodicals a manuscript might be sent before it was sold. Also documented in this series are the advances, royalties, and percentages paid on each sale.

IV. A. Agreement summary books 1942-1973 (6 boxes)

The agreement summary books contain important information distilled from contracts made between authors, periodicals, and publishing houses. The periodical books are arranged in date groups and are arranged alphabetically by author's last name within these groups. Each page contains contractual information for one title and includes the name of the author, the title of the piece, the manuscript number, the title of the magazine that bought the piece, the date the manuscript was sold, the total amount paid to Russell and Volkening, the publication date, and any rights and similar information. The publisher books contain the same information but for books. These files also include domestic and foreign sales, advances to the author, royalty amounts, and other sale information.

IV. C. Manuscript files 1940-1994 (21 boxes)

The manuscript files contain lists of authors, publishers, agents, and magazines; card files on manuscripts submitted to publishers and periodicals; and registers of manuscripts received by Russell and Volkening. The lists contain contact information for active and inactive authors represented by Russell and Volkening and publishers, periodicals, and foreign agents with whom they dealt. It is not clear why there are two separate active author files. They may have been kept by different agents over the years.

The manuscript cards are arranged in bulk date groups and are alphabetical by author's last name within these groups. Each card contains the name of the author, the manuscript title, where the manuscript was sent before it was sold, the date it was sent to each publisher or periodical, and the date it was returned to Russell and Volkening or was sold.

The manuscript registers are arranged chronologically and contain the manuscript number assigned to each manuscript as it was received by Russell and Volkening, the name of the author, the title of the manuscript, the date it was received, and the date it was returned to Russell and Volkening or the word "Sold" if it was not returned.
