- Abstract:** Theodorus Bailey Myers (1821-1888) was an American lawyer and autograph collector. Collection consists of letters and documents, as well as paper money, portraits and other prints of individuals prominent in American history during the colonial period, the American Revolution, and the nineteenth century. The collection contains letters and documents of English and European royalty and military figures, including Napoleon and his marshals, and an account by Don Juan de Casta of the siege of Havana, 1762.

## Biographical note

Theodorus Bailey Myers (1821-1888) was a lawyer and autograph collector. He was born in New York City, the son of Charlotte (Bailey) Myers and Mordecai Myers. Myers was educated at Columbia University; shortly afterwards, he began his career (1842). In that same year Myers married Catalina Juliana Mason; the couple had two children.

During the United States Civil War (1861-1865), Myers served with the Twelfth New York Militia. He also served in the position of quartermaster for the General staff, notably for General Wool. It was Myers's enthusiasm for American history and historical events that inspired him to collect historical autographs. Myers was ably assisted by another autograph collector, Dr. Thomas Addis Emmet. After Myers died in 1888, his wife donated the entire collection to the New York Public Library.

## Scope and content note

The collection consists of letters and documents, as well as paper money, portraits and other prints of individuals prominent in American history during the colonial period, the American Revolution, and the nineteenth century. Represented in the collection are the signers of the Declaration of Independence, governors of New Netherlands and New York, members of the Continental Congress, and generals and other military figures of the revolution, including American, British, French, and Hessian officers. Also included are the papers of General Daniel Morgan, 1777-1808; letterbook of General Mordecai Gist, 1777-1779; documents reflecting the activities of the Pennsylvania Assembly, 1754-1759; pay rolls and subsistence accounts of New York regiments, 1756-1758; and manuscript sermons of Lewis Rou, minister of the French Protestant Church in New York City, 1704-1750. In addition to prominent figures in American history, the collection contains letters and documents of English and European royalty and military figures, including Napoleon and his marshals, and an account by Don Juan de Casta of the siege of Havana, 1762. With few exceptions, printed maps, portraits, views, books, broadsides, bound volumes of paper money, and other printed materials were transferred to other divisions of the Library.
