Description Phelps, Dodge & Co. was founded in 1834 as the successor to the firm of Phelps and Peck, the leading importer of metals in the United States. With the dissolution of his partnership with Elisha Peck, Anson Green Phelps formed the new company in partnership with two of his sons-in-law, William E. Dodge and Daniel James. Phelps and Dodge remained in New York City, while James directed the firm's branch in Liverpool, England under the names of Phelps, James & Co. Phelps, Dodge & Co. imported metals, predominantly tin, from Great Britain and distributed them via commission agents throughout the United States and exported cotton, which Phelps, James & Co. sold to manufacturers in England. In addition to the metal trade, Phelps and Dodge invested heavily in the Pennsylvania lumber industry, brass, copper, and iron manufacturing in Connecticut, iron mining in Michigan and New Jersey, railroads, real estate, and banking. However, it was only after the death of William E. Dodge in 1883 and the purchase of two copper mines in Arizona that the multi-million dollar mercantile house was transformed into one of the nation's foremost mining companies, dealing predominantly in the mining, smelting, refining, and manufacturing of copper.

The records consist of incoming correspondence, financial and legal documents of the New York firm of Phelps and Peck, 1818-1834, and its successor Phelps, Dodge & Co., 1834-1869. The bulk of the material dates from the founding of the firm in 1834 to the death of Anson Greene Phelps in 1852. The letters, arranged chronologically, are from commission agents, customers, suppliers, and those concerned with the firm's manufacturing, lumber, real estate, railroad and banking interests. The letters from commission agents include detailed accounts of their sales of Phelps, Dodge tin plate, wire, and other materials, inlcuding the amount, name of purchaser, price paid, commission deducted, bills of lading for shipment of goods, etc. In addition, there are a considerable number of letters from Daniel James of Phelps, James & Co. discussing the Liverpool side of the business.
