#### **Biographical Note**

Ann Andrews (1895?-1986), was a stage actress for the first half of the twentieth century with a wide range of friends in theatrical and motion pictures circles. Born in Los Angeles, California, on Oct. 13, 1895 (some sources say 1890), Ann Andrews studied at Egan's Dramatic School in Los Angeles, and made her stage debut in the title role of *Nju* at the Little Theatre in Los Angeles in October 1916. She repeated this role for her New York stage debut the following March. Her subsequent stage appearances included *Seven Days Leave* (1917), *The Hottentot* (1920), *Her Temporary Husband* (1922), *The Captive* (1926), George S. Kaufman and Edna Ferber's *The Royal Family of Broadway* (1927), Preston Sturges' *Recapture* (1930), Kaufman & Ferber's *Dinner at Eight* (1932), *Dark Victory* (1934), *First Love* (1936), *When We Are Married* (1939) and *Spring Again* (1944). Ann Andrews also toured the United States and Canada in stock, and appeared in two motion pictures, *The Girl by the Roadside* (1917) and *The Cheat* (1931).

#### **Scope and Content Note**

The Ann Andrews papers span 1918-1963, and consist of letters from her many friends in show business. Among Ms. Andrews' well known friends and correspondents were Katharine Cornell and her husband Guthrie McClintic, Marc Connelly, Dorothy Parker and her husband Alan Campbell, Grace George, C. Aubrey Smith and his wife Lady Isabel Smith, Lenore Ulric, Carl Van Vechten, and Evelyn Varden. Of particular interest are the letters from actress Grace George (1879-1962), wife of Broadway producer William Brady, who writes about her husband's declining years and about working on the film *Johnny Come Lately* (1943) with James Cagney; and the letters from actor C. Aubrey Smith (1863-1948) on a variety of topics. After Sir Aubrey's death his wife Lady Isabel picked up the correspondence and continued it for a number of years. Many of Ann Andrews' correspondents mention her cats, of which she owned more than a dozen.
